3Es to Achieve --- ACCA Membership

To gain ACCA membership, an individual must complete the 3Es of ACCA:

1. Exam

This involves completing all required ACCA examinations across the Applied Knowledge, Applied Skills, and Strategic Professional levels, demonstrating your technical knowledge and professional competence in accounting, finance, and business.

2. Experience (PER)

PER stands for Practical Experience Requirement. It requires completing 36 months of relevant work experience and achieving the required performance objectives to develop real-world professional skills.

3. Ethics (EPSM)

EPSM stands for Ethics and Professional Skills Module. This module helps develop ethical awareness, professionalism, and essential skills such as communication, leadership, and decision-making through realistic business simulations.

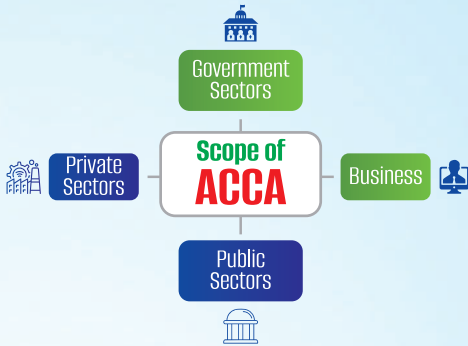

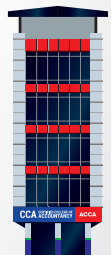
